

Editorial guidelines

CODISCO PROCEEDINGS

The papers must be sent to codisco@gmail.com in .rtf or .doc(x) format, together with another file indicating author's data and her contact information. Articles will be sent to at least two referees for anonymous evaluation. The steering committee chooses two anonymous referees who will receive articles without knowing the authors' name. The referees' motivated opinion will be communicated (anonymously) to the authors. The evaluation will be based on the following criteria: relevance of the topic, originality, clarity of presentation, knowledge of the existent international literature, methodological accuracy. The editorial staff communicates a first favourable evaluation, the Director communicates to the author in which issue of the journal her paper will be published.

Authors must adopt the following editorial criteria:

- **articles** should not exceed **30.000 characters**, notes and bibliography included;
- in order to assure the **anonymity** of the article, authors' names, as well as their addresses must be omitted in the article and reported as a separated file. For the same reason, authors must make anonymous their own article, avoiding explicit references at their work;
- **figures** and **tables**, including notes and taglines, must be inserted in the text and also attached as separated files in a standard digital format (.jpg .tiff .png .gif);
- **quotes**: must be put in guillemets («...») and, in case of a further quote, in quotation marks ("...").
- **ibid.** is used to indicate the same volume previously quoted but at a different page, **ivi**, same volume and same page, **cf.** in order to refer to any text;
- **bibliography**: references must be put directly in the body text, following the «Author, Date» system and indicating the author's name, the year of publication and, if necessary, the page number. For example: Chomsky (1965), or (Chomsky 1965), or (Chomsky 1965, 65-68); in case of multiple authors commas must be used: (Richerson, Boyd 2005), (Hauser, Chomsky, Fitch 2002); in case of many authors: (Baron Cohen *et al.* 1985). Works must be cited alphabetically following authors' last name and chronologically when are reported many works of a single author. For what concerns the bibliographic style, we adopt a very simple personal one:
